- b) Motion by Hager and seconded by Jeno to pay Met-Con Construction \$500.00 for the use of a crane for the installation of the middle stone. All members voted aye for approval. Motion carried.
- c) Motion by Hager and seconded by Jeno to pay Nagel's Sod \$600.00 for two eagles for placement at the Veterans Memorial. All members voted aye for approval. Motion carried.

Moving of the Donation Sign: Marie Sexton is in attendance to discuss the placement of the donation sign. The committee felt that they should address this topic before acting on the landscaping.

Marie Sexton addressed the committee on the location of the donation sign. Ms. Sexton thought that the placement of the donation sign was temporary. Ms. Sexton asked the committee to consider moving the sign further away from the memorial. John Hager talked about a future sidewalk running along the Memorial.

Motion by Schultz and seconded by Hagen to leave the donation right where it is. All members voted aye for approval. Motion carried.

Old Business:

a) Landscaping: Nagel's Sod will be donating all the materials and labor for the landscaping at the Veterans Memorial. The committee is entirely grateful for this generous donation.

Schultz received two quotes for the name tablets. One quote was for a 4ft. tablet cut straight across for \$6,246.00 a piece. The other quote was for a 5 ft. tablet cut at an angle for \$7,560 a piece. The group discussed the funds and thought the tablet cut at an angle would look very nice. Mr. Heerema stated that if the tablets were ordered by the middle of July, they could be here before the end of the year.

New names for the tablets will be collected and then sent to be engraved in St. Cloud.

Motion by Hagen, seconded by Hager to order two 5 ft. tablets cut at an angle for a total purchase price of \$15,120.00. All members voted aye for approval. Motion Carried.

Vern Jeno addressed the committee on his work done with the donation sign. In lieu of submitting a bill, he would like Jeno Welding on the donation sign.

The committee agreed that Jeno Welding will be added to the donation sign.

b) Placement of new names on the tablets. – The Committee discussed the option for people to request where their name will be on the tablets. As long as the request is a logical possibility, requests for a particular spot for a name will be allowed.

Vietnam Memorial Wall Processional Escort – August 31, 2016 between 3-4 p.m. the wall processional will be going along Main Street in Medford. The committee is going to get the word out and get as many people as possible to stand along Main Street in honor. Kniefel will see about getting something out on Facebook. Kniefel will look into the cost of little flags to hand out.
